Important Instructions

Duly completed Application Form should be sent by Registered Post, Courier or by Hand to Pankaj Baiswar (Plant Pathology), Secretary, Indian Association of Hill Farming (IAHF), & Principal Scientist, Division of Crop Science, ICAR Research Complex for NEH Region, Umiam-793103, Meghalaya, so as to reach not later than 30th December, 2023.

- IAHF calls for **IAHF YOUNG SCIENTIST AWARD 2021 and 2022** (Total 02 awards)
- Only one award will be given every year across the discipline
- Award carries a certificate and a memento.
- The age of the applicant on the 31 Dec. of the year for which applied for award should be less than 35 years.
- Life membership of IAHF is prerequisite for the award. At least three years of service to Govt./Non Govt. organizations (permanent/contractual) in any hill stations is required to apply for the young scientist position.
- Attach a copy of age proof, evidence for service in Hill station and reprint of 5 most important research papers.
- Provide soft copy of application along with evidences for publication/other claim in the USB drive with appropriate headings for easy reference (Naas Rating of Year 2023 will be followed).
- Claims without evidence (**soft copy in USB drive**) will not be considered for scoring.
- Submit TWO COPIES of Application through proper channel
- Application not received within closing dates will not be considered.
- Only application forwarded through Head of the Institute/ IAHF Fellow/ Fellow of any recognized professional National Society will be entertained by the society (*Proof to be attached by the person forwarding the application in case of Fellow other than IAHF*).
- Final decision of Society President will be binding in all cases.
- Achievements/ Publication etc up to the closing date will be considered for IAHF Award irrespective of year of Award.
- Complete application (hard copy) may be kept within 30 pages including enclosures.

- **b. Next best 10 papers** (NAAS rating 5 will get 0.5 mark each, for papers less than 05 ratings say 02, marks will be get 02/05 x 0.5= 0.2, similarly papers more than 05 rating will get proportionately higher marks. First author or corresponding author to score full marks, others 0.75) (Naas Rating of Year 2023 will be followed)- Max. 05 marks
