1. Agenda No.1. –Fund requisition for ABI

The ITMC had approved the fund requisition of Rs 2,00,000/- (Rupees Two Lakhs only) under Capital Head for forwarding to the funding agency of ABI.

2. Agenda No 2. Price fixing of Megha Maize1, Megha Maize2, RC Manichujak 2 and Umiam Soybean 1.

A recommendation was made by the Chairman that a separate Committee be formed to look into the price fixing aspect of such varieties. The composition of such Committee should include the following officials:

1. Head, DCS (Chairman)
2. One Scientist each from Agronomy and Economics
3. Farm Manager
4. Chief Administrative Officer (Sr. G) or Representative

5. Sr. FAO or Representative

It was decided by the ITMC that such Committee shall look into price fixation of the varieties as per ICAR and IP & TM guidelines.

Action : HOD, DCS

3. **Agenda No. 3** Submissions of varieties - Megha Maize 1, Megha Maize 2, RC Manichujak 2 and Umiam Soybean 1 to Agri innovate for commercialization.

It was decided by the ITMC that once the price-fixing committee is formed, such variety submission to Agriinnovate shall be taken up for consideration.

4. **Agenda No. 4: Miscellaneous matters.**

It was observed by the Chairman that a technology pertaining to DAFS i. e African Swine Fever Kit has the potential for commercialization and steps should be taken for commercialization of such technology at the earliest. Such recommendation was agreed by the ITMC and HOD, DAFS ensured future steps to be taken in this regard.
